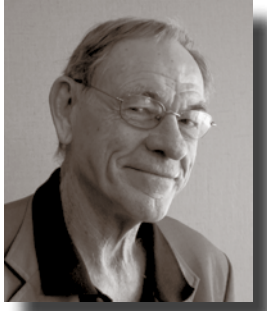

## *Richmond Retirees' Chapter: February 2015 Minutes*

The 2015 February Meeting of the Retiree Chapter was held on February 9 at Imperial Plaza. The meeting was conducted by Walt Pulliam, President. He asked that everyone check the listing that was being circulated to ensure that all information was correct. Walt welcomed everyone, and introduced Kathy Lackey, who was attending the meeting for the first time.

He announced that Dee Esser, Vice President, is trying to get a speaker from Anthem for our next meeting. Winfree Mountcastle informed us that based on his calculations our Cost of Living Adjustment (COLA) for July 1 should be 1.62%. This will be reflected on your August check.

Dee Esser introduced Susan Davenport, Director of Communications and Marketing for VA Repertory Theatre (VA Rep). Prior to her role at VA Rep, Susan worked with many nonprofits and community projects including Acts of Faith Theatre Festival and Go Read. She currently serves on several non-profit Boards including Family Lifeline, Elk Hill Farm and the Jenkins Foundation.

Barksdale started in Hanover Tavern. Bruce Miller and Phil Whiteway were doing educational programs for schools. They merged Barksdale and Theatre IV in 2012. There are now four venues: Hanover Tavern, Children's Theatre at Willow Lawn, November Theatre and Cadence Theatre.

Bruce and Phil feel it is very important to be apart of the community. For more than 30 years, they have supported Hugs and Kisses in all schools. During the presentations they are always accompanied by staff from the Department of Social Services. This presentation is a sexual abuse program. They also partner with the VA Civil War Museum, VA Museum and the SPCA. Additionally, they discount tickets to Senior Citizens and children who cannot afford to pay.

Acts of Faith was started by Bruce Miller, Janet James and other Richmond area pastors. It is an open dialogue between different faiths. Sixteen area theatres participate and many denominations, including Islam and Jewish faiths.

VA Rep is offering three plays. "The Maggie Walker Story" is in the Children's Theatre. "The Whipping Man" takes place in Richmond in April of 1865 at the end of the Civil War. Its characters are the Jewish son of the former owner and two former slaves. The play

deals with the changes in their relationships. The third play is "You're A Good Man Charlie Brown."

Ms. Davenport stressed that anyone can become involved with the theatre by volunteering to serve as ushers, helping with costumes and sets, or working in the gift shop.

Several members brought up the difficulty of parking at the November Theatre. Susan stated that for \$8.00, you can use valet parking or they now have several free parking lots nearby. Members also stated that it is difficult to get to Hanover Tavern due to the distance. They wish more plays would be at Willow Lawn. Susan was asked if the cast members are paid. Susan stated that they are paid. Some are unionized and get a larger pay. Even the interns are paid and some get housing as well.

VA Rep now has a newsletter and she passed around a list for email addresses of those who are interested in receiving a copy. She also talked about Coffee and Conversation which is held once a month on the second Tuesday at 9:30 a.m. at the Willow Lawn Theatre.

Kermit Spruill gave the Treasurer's Report for Faye Spruill. He reported that our current balance is \$1,914.18.

Walt gave a Legislative Update: There could be a pay raise for State employees. A minimum payout for life insurance is still alive. The increase in the Health Care Credit did not go anywhere. There has been some discussion about raising our health care deductible.

He also reminded us about the availability of scholarships. It can be for children or grandchildren. Applications are available online or call the VGEA office.

Remember that Monday, February 16 is Legislative Day. Anyone who is interested should meet at the VGEA Office at 8:30 a.m..

Our next meeting will be Monday, March 9, beginning at 11:30 a.m. at Imperial Plaza.
