



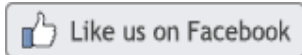

**Lagging Revenues Jeopardize 2016
State Employee Salary Increase**

Virginia revenues so far this fiscal year have not met projections, and need to improve by June 30 to ensure the 3 percent raise approved by the General Assembly and signed by the Governor goes into effect.

The salary increase - as they all are - is contingent on the state meeting forecasted General Fund revenue numbers. To help boost the Commonwealth's budget, Governor McAuliffe urged state agencies to cut expenses in April, when the revenue shortfall became apparent. The VGEA staff will continue to monitor this top priority closely. We will know more and report to you in a few weeks when the June 30 revenue numbers are released.
