Get informed to vote for *your* best candidates on Election Day, tomorrow, Tuesday, November 7!

As most active and retired employees of the Commonwealth are aware, compensation, benefits and retirement options for state workers are all determined by our state legislature.

Many of those decision-making positions are **up for election tomorrow, including all 140 House of Delegate seats** (although not all are contested), **the Governor, Lieutenant Governor, and Attorney General.**



At our most recent Regional Meetings we distributed a booklet produced by the State Board of Elections called [Elect No Strangers](#) (click [this link](#) for an electronic version, which **includes links to each candidate's website**). It's a **directory of who is running** for each open position, so you can **determine who you will choose before you get in the ballot box.**

The VGEA urges you to ***be an informed voter!*** The association is nonpartisan, and will forward the legislative goals of Virginia state employees with whomever is chosen; however, **if those elected already have favorable opinions of public workers it will help us immensely.**
