- 4% raise, effective 7/1/24 (FY25) [\$220.8 million],
- 1% bonus, effective 12/1/24 (FY25) [\$53 million] [\$55.12 million]
- 1% raise, effective 6/10/24 (FY26) [\$44.8 million] 4% raise, effective 6/10/24 (FY26) [\$229.6 million], and
- 1% bonus, effective 12/1/25 (FY26) [\$54.7 million] [\$59.1 million.]
